She is currently an Extraordinary Lecturer in the Department of Economics at the University of Pretoria and a Fellow at the Infrastructure Institute at the School of Cities at the University of Toronto. In addition, Astrid has worked extensively with city governments across Africa and Asia in her diverse roles, including previously as an urban economist with the African Development Bank and Policy Director at the International Growth Centre. She holds an MA in International Economics and International Development from Johns Hopkins University. In 2016, she was nominated by the University of Cape Town as one of Africa's Young Leaders and in 2020 she received Johns Hopkins University's Outstanding Recent Graduate Award, for her work on urbanisation.
